## HEALTH OF YOUR PET:

The pet you are adopting from the Midland Humane Coalition (MHC) may have been exposed to various diseases from proximity to other animals prior to arriving at the Center. In addition, the physical conditions of some animals may have been less than ideal due to the conditions the animal may have had to endure prior to arriving at the Center; consequently, there may be some risk in adoption. We strive to carefully screen our animals and to inform prospective adopters of any perceivable problems however, there may be problems we are not aware of at the time of adoption. The adoption fee, and only the adoption fee, may be refundable if the adopted animal is diagnosed with a life-threatening disease (i.e. Parvo, Panleukopenia, Distemper). Documentation from a licensed veterinarian must be provided when requesting a refund.

I understand that I may not give the animal to anyone other than Midland Humane Coalition in the event I can no longer care for the animal, unless previously approved by Midland Humane Coalition.

\_\_\_\_\_ I agree to keep the animal as a family pet in a safe, humane and caring environment and to provide food, shelter, and medical attention as needed for the life of this animal.

\_\_\_\_\_ If adopting a CAT, I agree to keep it indoors only and not to have it declawed.

If adopting a DOG, I agree that it will not be chained or tethered as a means of confinement.

\_\_\_\_\_ Midland Humane Coalition makes no guarantees as to the health or temperament of any animal and will not be held liable for any resulting costs or damages.

\_\_\_\_\_ As the adopting party, I agree that failure to comply with this contract/agreement could result in being required to return the pet to the Midland Humane Coalition.

\_\_\_\_\_ I give Midland Humane Coalition and its subsidiaries permission to photograph/record and use these photos/videos of me and/or my underage child under my legal guardianship.
